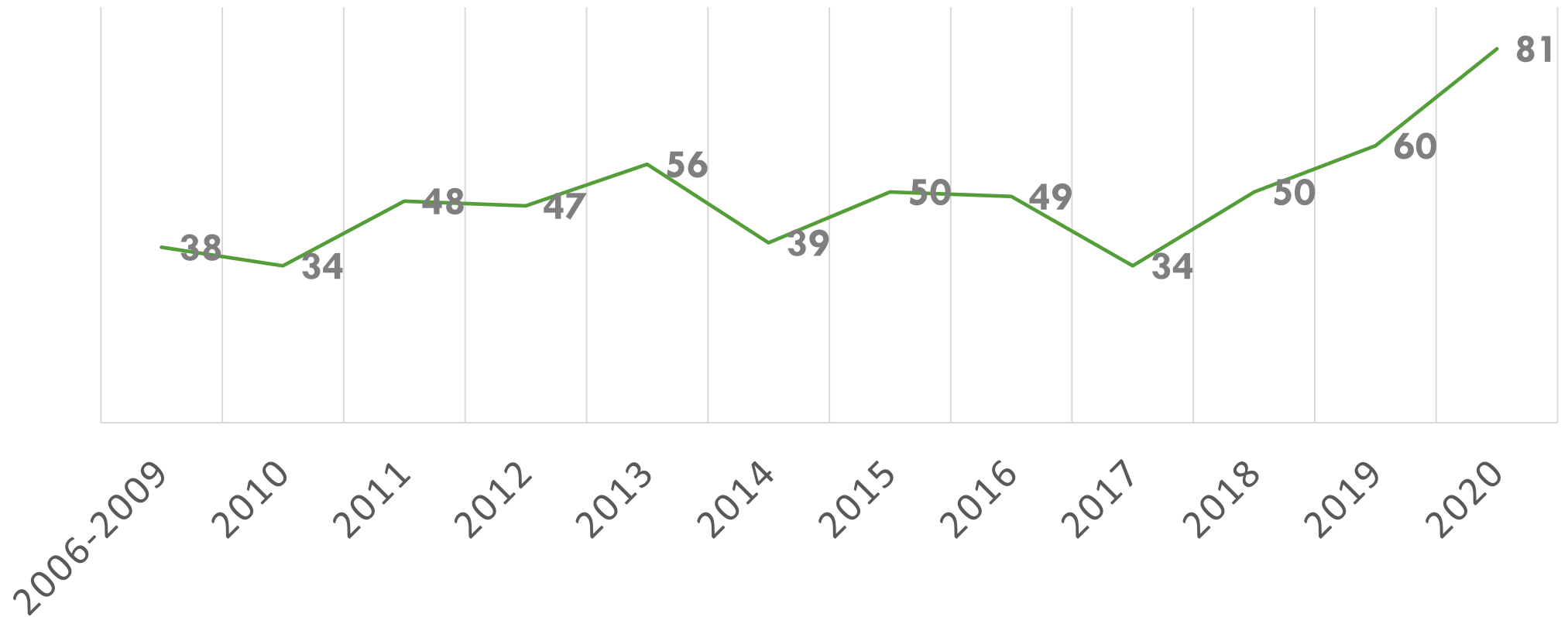
METHODOLOGY

- 2006-2020
- circa 600 cases
- only recognition and enforcement proceedings
- only judgements adopted upon court review of applications to recognize and enforce

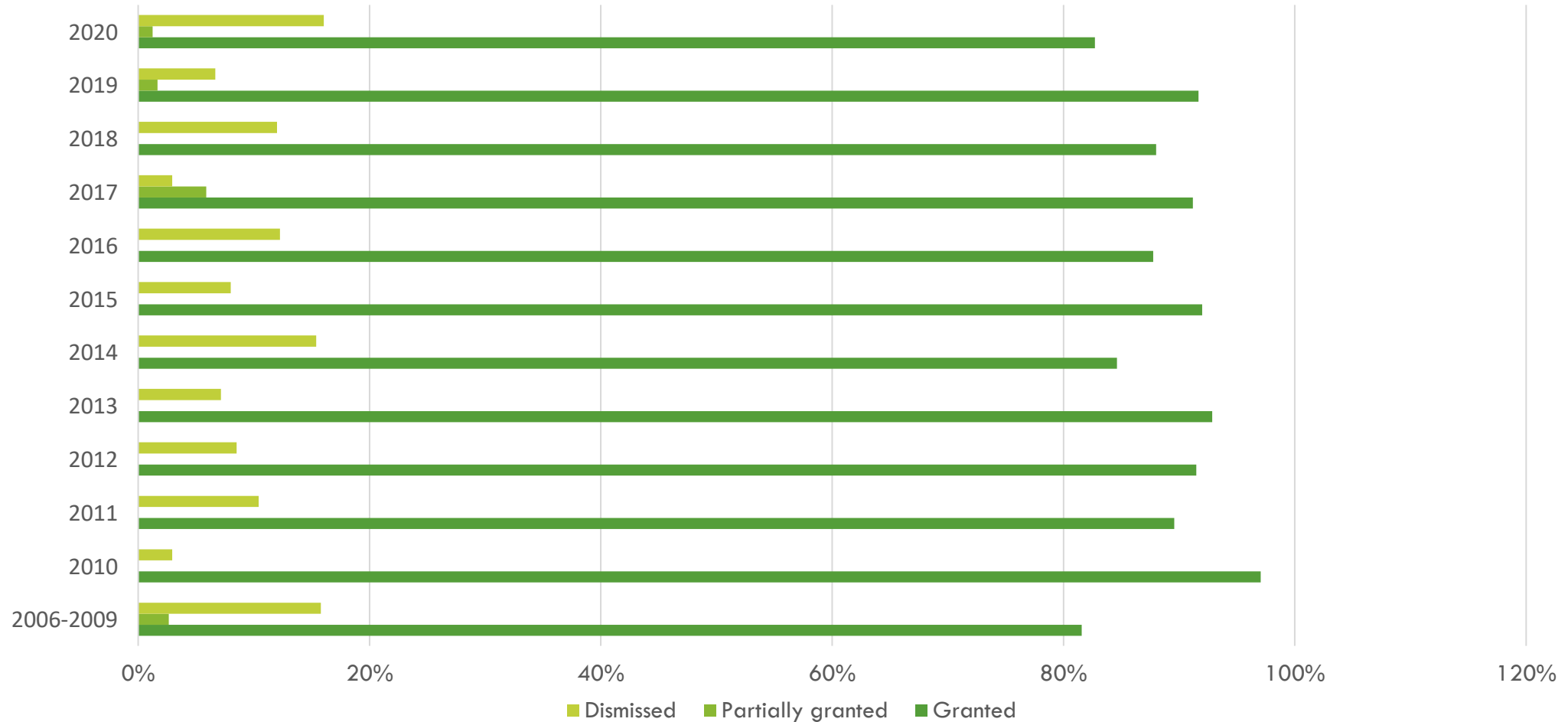
METHODOLOGY

- study performed by members of working group with several double-checks to ensure quality, but 'errare est'
- study based on public register of court decisions, which may be not 100% accurate, especially with respect to older decisions
- court decisions may provide limited picture of the case (as to raised and considered grounds for refusal, applicable arbitral rules, parties to the case, etc)

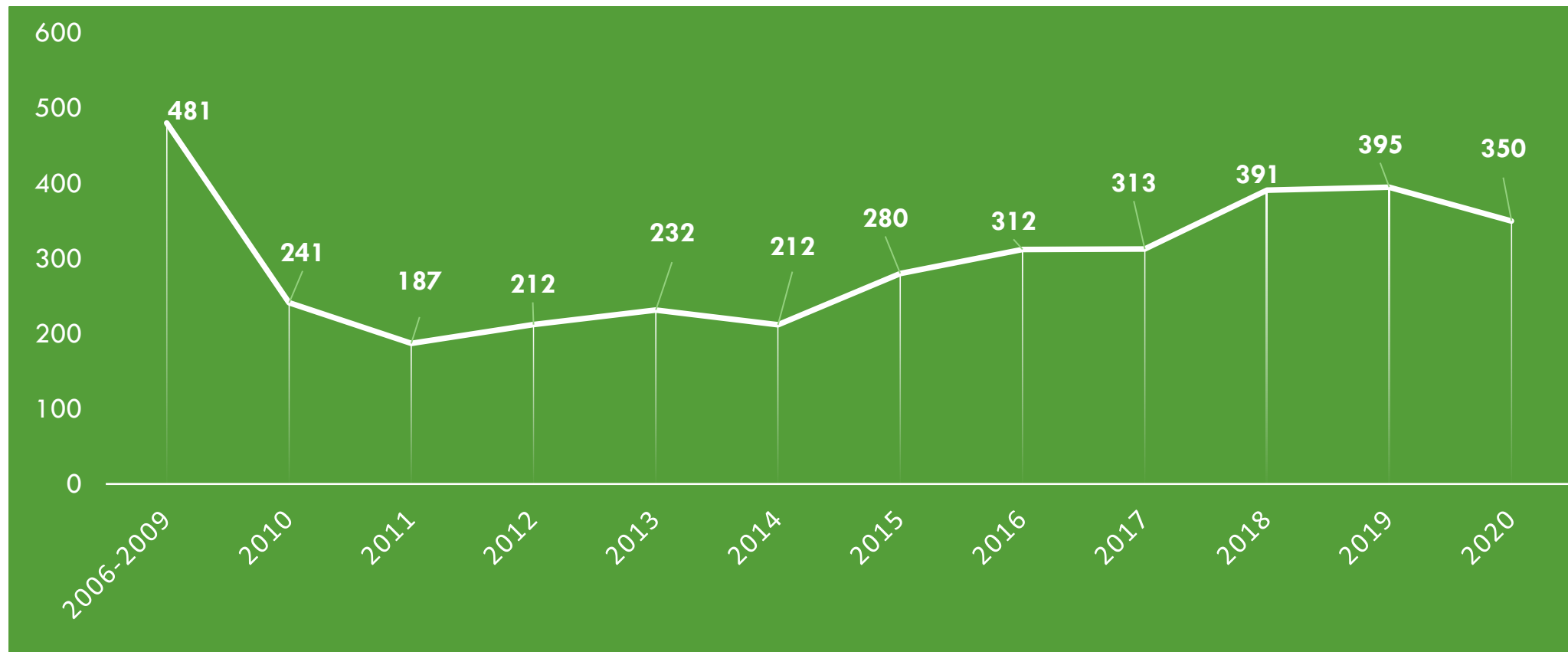
APPLICATIONS PER YEAR



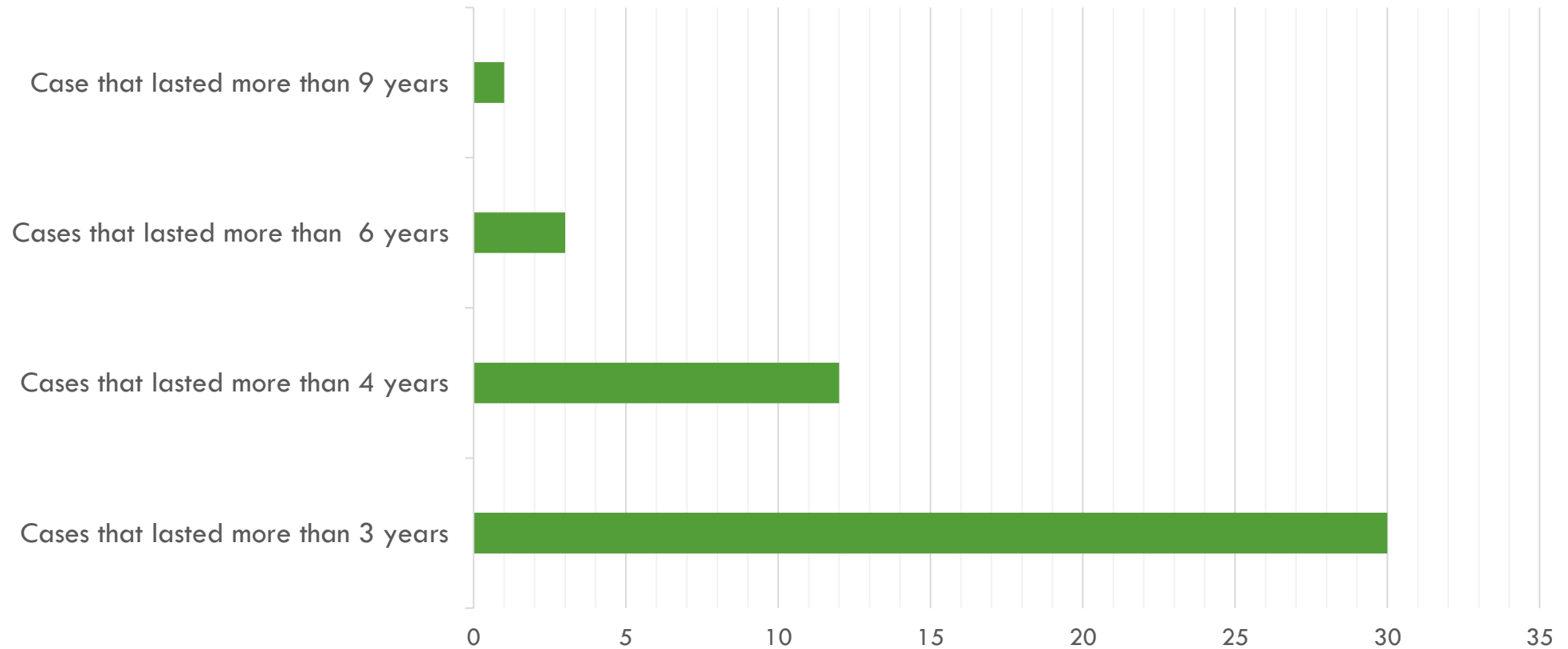
APPLICATIONS GRANTED / PARTIALLY GRANTED / DISMISSED



DURATION OF CASES (ANNUAL)

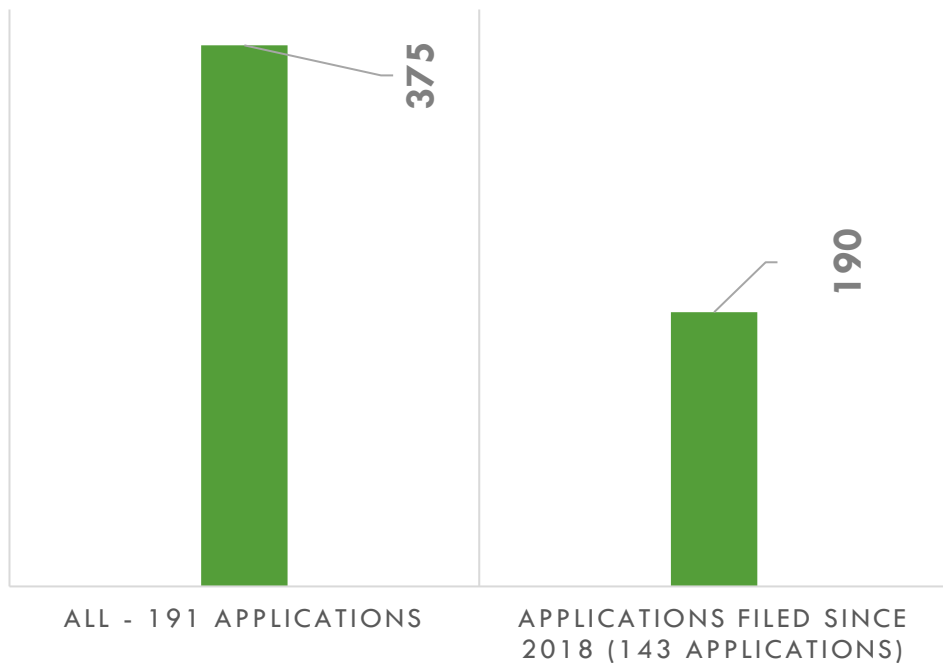


RECORD BREAKING CASES

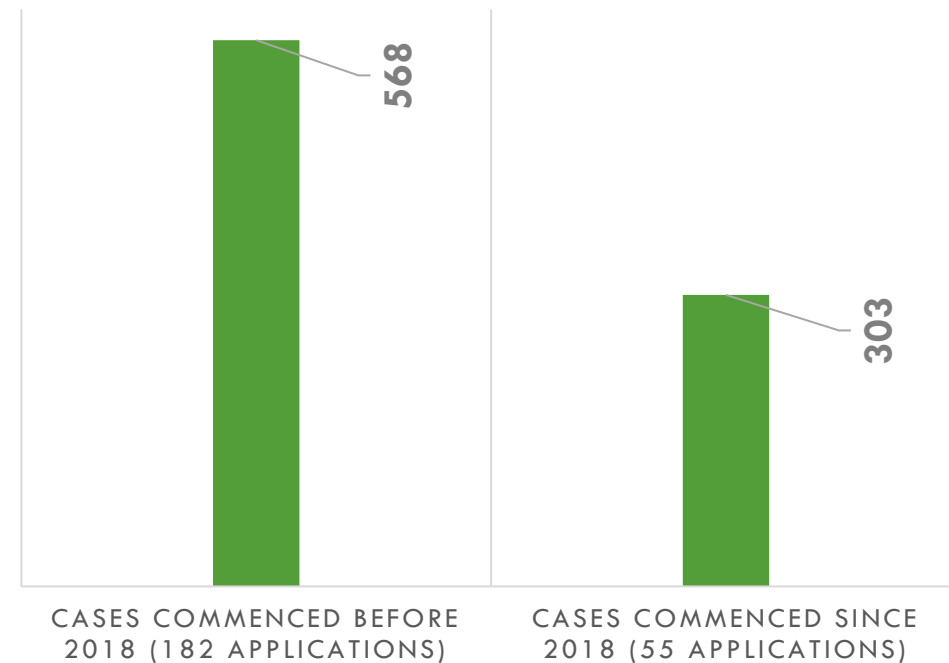


IMPACT OF 2017 REFORM - DURATION

Cases decided since 2018

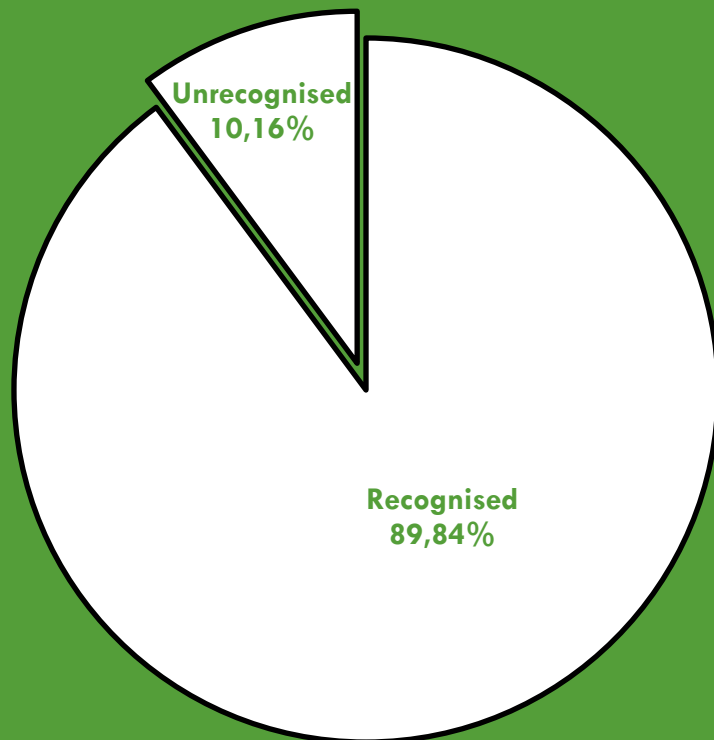


Contested cases: before / after 2018

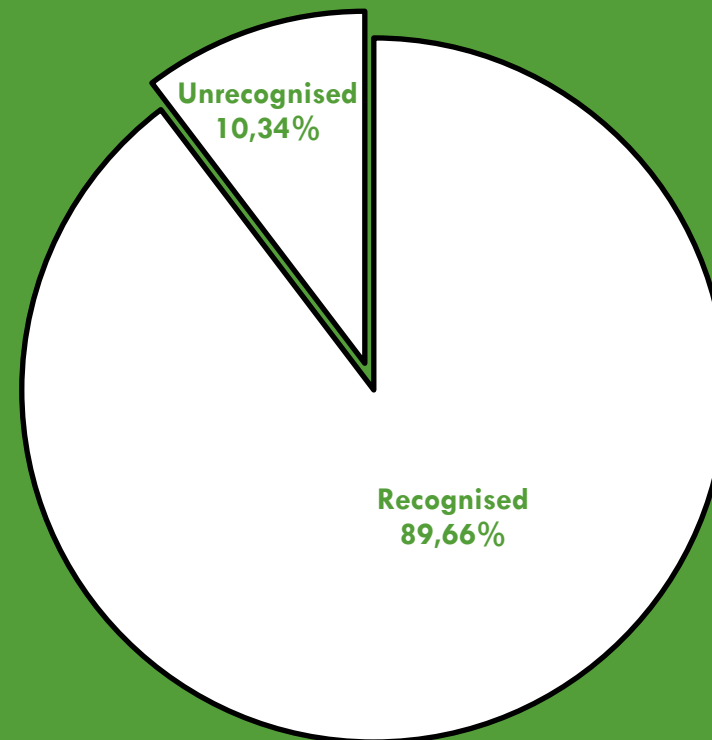


IMPACT OF 2017 REFORM – RECOGNITION

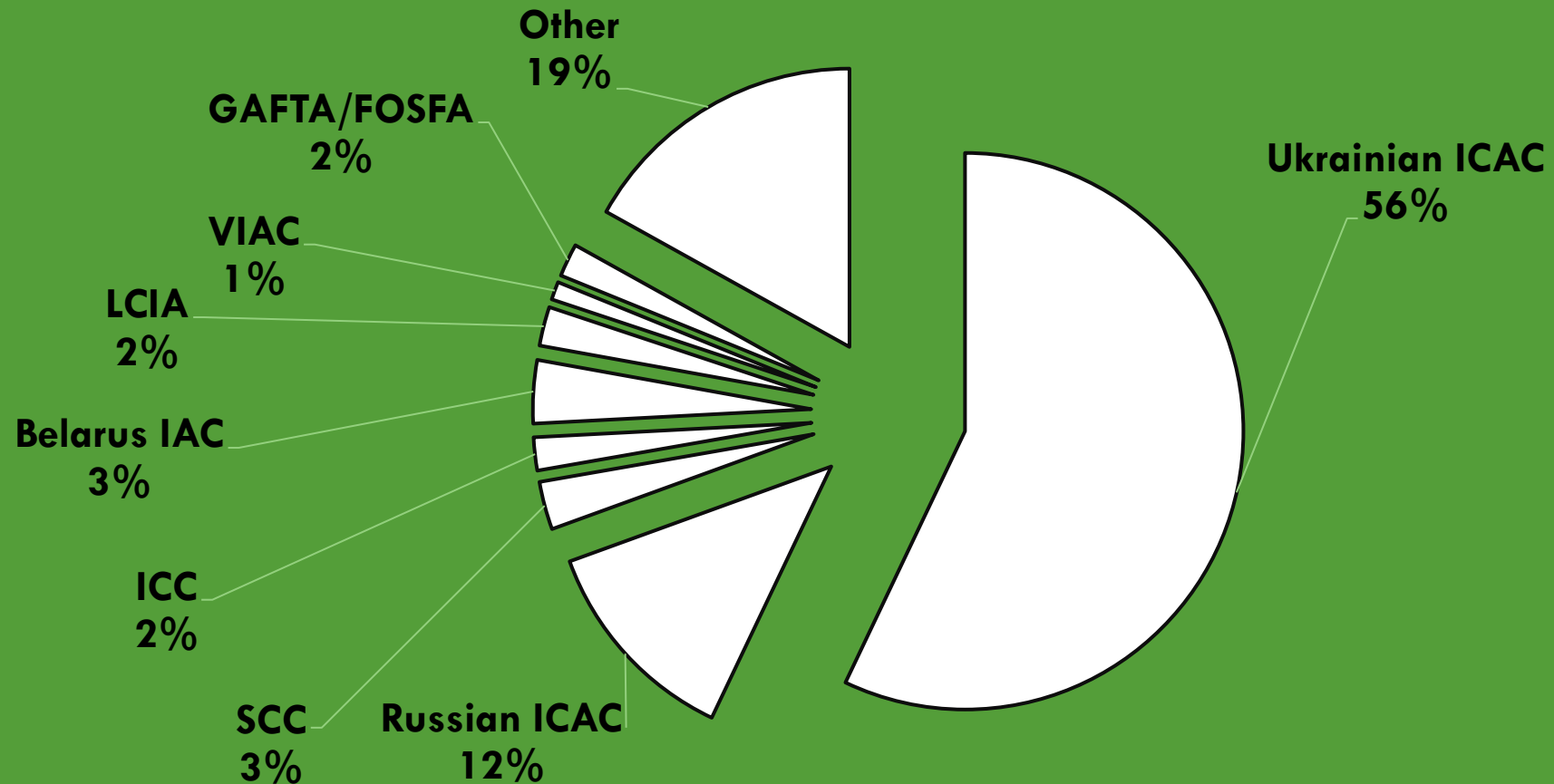
BEFORE 2018, 443 CASES



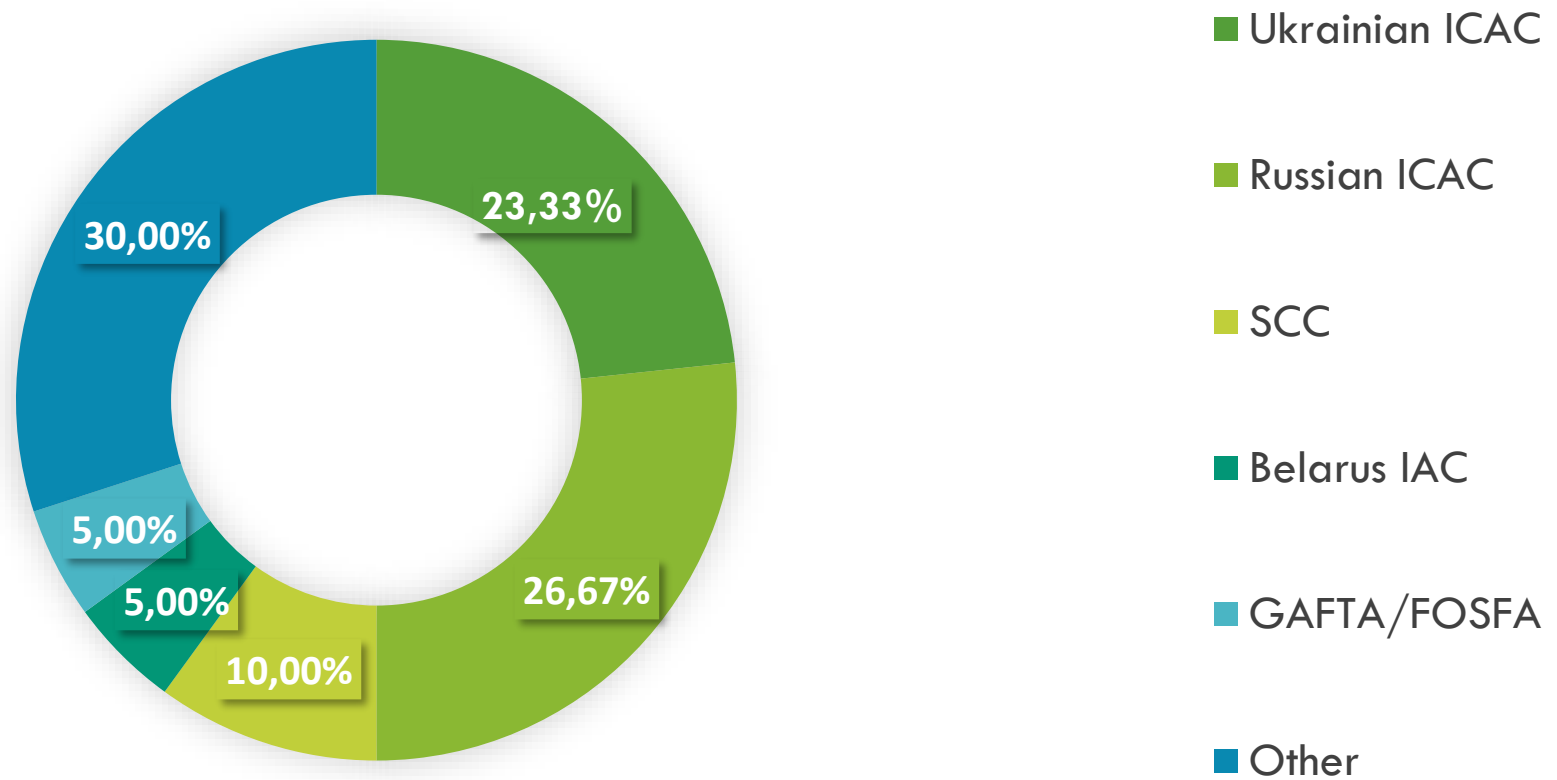
AFTER 2018, 145 CASES



INSTITUTIONAL RULES 2006-2020

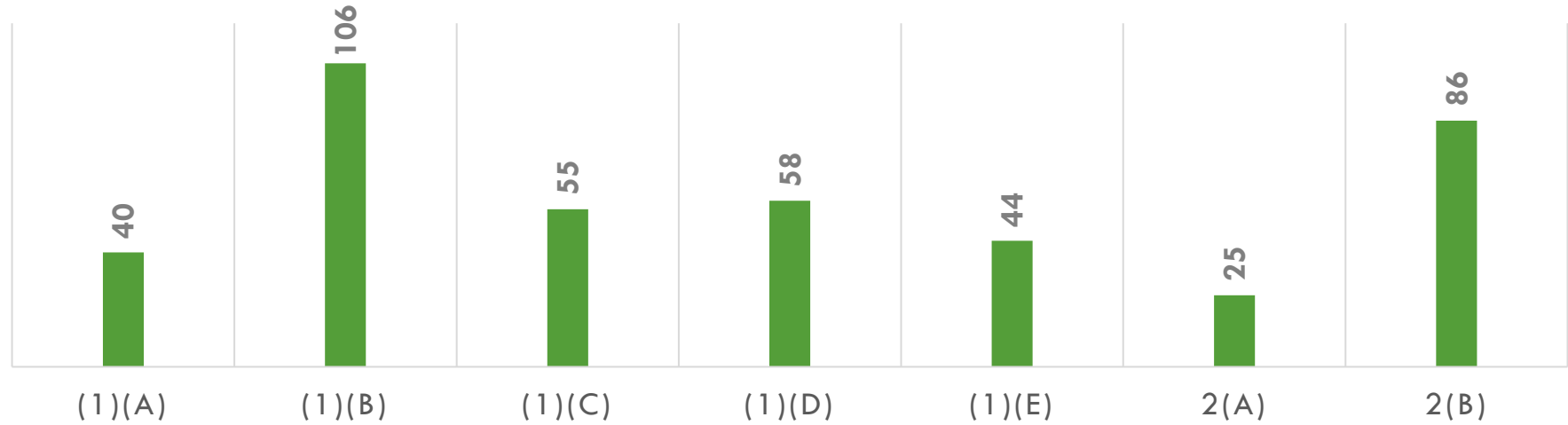


NON-RECOGNIZED AWARDS (ABOVE 5%)

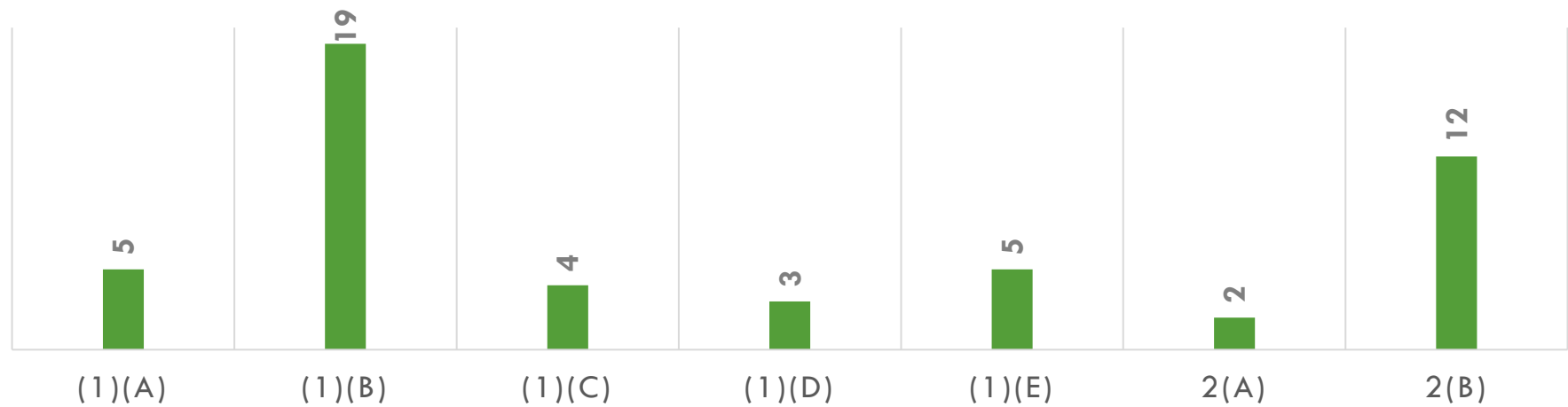


GROUNDS FOR REFUSAL

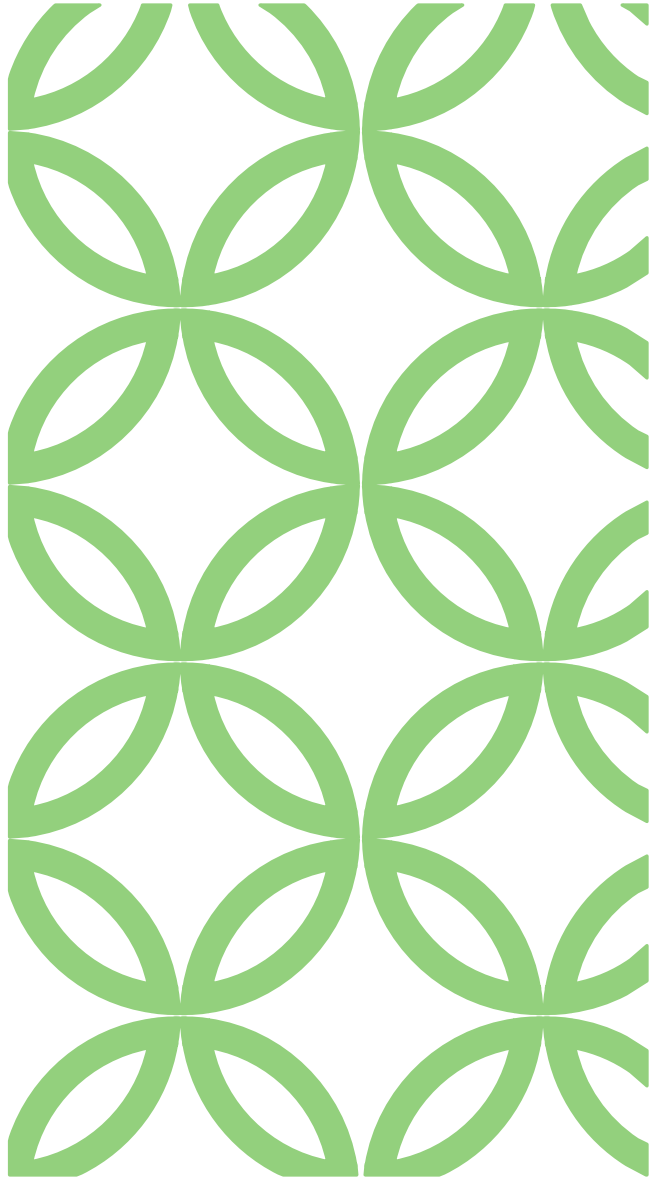
